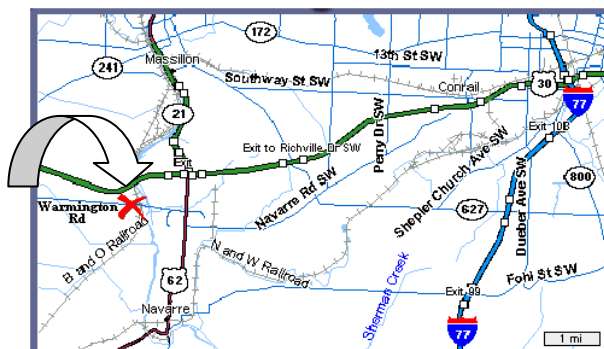

If the Participant (or parent/guardian) and the Activity Sponsor cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.

I further agree that in the event of disciplinary action or if the health of the participant makes it necessary, at the discretion of the Sponsor, the participant may be forthwith returned home at the parent/guardian's expense.
